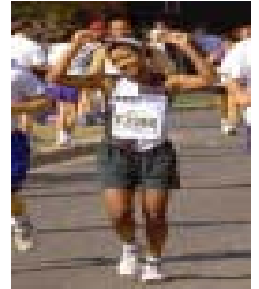

REGISTRATION

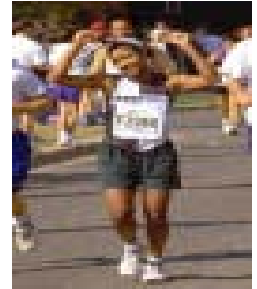

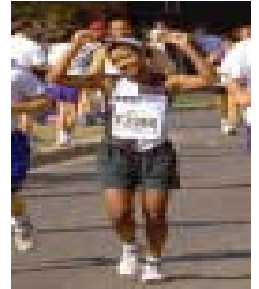
